Sub: Dr. NTRVST- P&C – Revision and fixation of Package rate to ‘Maintenance HemodialysisforCRF’under the Schemes being implemented by Trust – Circular instructions - Issued.

It is to inform that the package prices of all the identified Procedures under the Schemes of Dr. NTR Vaidya Seva, Employees Health Scheme & Working Journalist Health Scheme vide refs. 1st&4th cited have been revised and fixed as per the orders issued by Govt. vide G.Os. 2nd&3rd cited and that the Network Hospitals are claiming the packages so fixed including the following package prices for Maintenance HemodialysisforCRFfor the services provided to the beneficiariesof the Schemes.

- i. Package price for Maintenance HemodialysisforCRF under Dr. NTR Vaidya Seva Scheme – Rs. 12,500 /-
- ii. Package price for Maintenance HemodialysisforCRFunderEmployees Health Scheme& Working Journalist Health Scheme -Rs.15138/-

It is also to inform that, in the weekly review meeting held on 24.07.2017 with the Principal Secretary to Govt., HM&FW Dept., Chief Executive Officer of the Trust and other (5) HOD's of Medical and Health under the Chairmanship of Hon'ble Health Minister of A.P. , it was discussed among others that the package price for Maintenance Hemodialysis for CRF shall be revised and fixed as per the rate finalized in Tender Notification issued by the Director of Medical Education, A.P., Vijayawadafor providing Dialysis services at the Teaching Govt. Hospitals, Visakhapatnam, Kurnool, Guntur, Kakinada,Vijayawada, Srikakulam and Tirupathi.

Trust has, therefore decided to revise and fix the package price of Rs.1028/- per cycle (Rs. 10,280/- for Minimum of 10 cycles) for the procedure of Maintenance Hemodialysis for CRF.

Accordingly, Package price for the procedure of Maintenance Hemodialysis for CRF is hereby revised and fixed under the Schemes of Dr. NTR Vaidya Seva/ Aarogya Raksha Scheme and Employees Health Scheme / Working Journalist Health Scheme as indicated below:
